## Client Money Standing Authority 客戶款項常設授權

The Client Money Standing Authority covers money held or received by SINOSTAR in Hong Kong (including any interest derived from the holding of the money which does not belong to SINOSTAR) in one or more segregated account(s) on my/our behalf ("Monies").

## Client Securities Standing Authority 客戶證券常設授權
